1. What is the research study about?

You are invited to take part in this research evaluation study. This study is a process and impact evaluation of NACBO, the National Alliance of Capacity Building Organisations in Australia.

The six NACBO organisations are:

Belonging Matters (VIC)
Community Resource Unit (QLD)
Family Advocacy (NSW)
Imagine More (ACT)
JFA Purple Orange (SA)
Valued Lives (WA)

The organisations work to build skills, knowledge and confidence of people with disability and their families so that people with disability can identify and realise their goals, lead valued and inclusive lives and have leadership roles. 6. What will happen to information about me, or the person I support?

By agreeing to do the survey, you consent to the researchers collecting and using information about you for the research study. The research team will store the data collected from you for this research project for a minimum of 7 years after the completion of the research.

The information about you will be stored in a **non-identifiable format** where your identify will be unknown.

Information collected from you, your survey **responses about your experience** of capacity building provided by NACBO will be stored in an electronic format on a UNSW password protected OneDrive folder. The folder will only be accessible to the approved research investigators.

The information you provide is personal information for the purposes of the Privacy and Personal Information Protection Act 1998 (NSW). You have the right of access to personal information held about you by the University, the right to request correction and amendment of it, and the right to make a complaint about a breach of the Information Protection Principles as contained in the PPIP Act.
